**A BYLAW TO ESTABLISH PUBLIC NOTICE FOR COUNCIL  
ELECTIONS IN THE RM OF MARTIN NO 122**

The Council of the Rural Municipality of Martin No 122 in the Province of Saskatchewan enacts as follows:


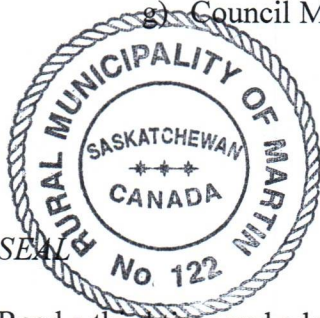
**PUBLIC NOTICE / ADVERTISING**

1. **Notice of Call for Nominations** and if necessary **Notice of Call for Further Nominations** shall be posted:
  - a) in the Municipal Office; and
  - b) in the Post Office in the Town of Wapella; and
  - c) in *The World-Spectator* newspaper; and
  - d) on the Municipal Website ([www.rmofmartin.com](http://www.rmofmartin.com)); and
  - e) emailed to RM Ratepayers who have agreed to receive emails.
2. **Notice of Abandonment of Poll** shall be posted:
  - a) in the Municipal Office; and
  - b) in the Post Office in the Town of Wapella; and
  - c) on the Municipal Website ([www.rmofmartin.com](http://www.rmofmartin.com)); and
  - d) emailed to RM Ratepayers who have agreed to receive emails.
3. **Notice of Poll** and **Notice of Advanced Poll** shall be combined on one form and posted:
  - a) in the Municipal Office; and
  - b) in the Post Office in the Town of Wapella; and
  - c) in *The World-Spectator* newspaper; and
  - d) on the Municipal Website ([www.rmofmartin.com](http://www.rmofmartin.com)); and
  - e) emailed to RM Ratepayers who have agreed to receive emails.

Two handwritten signatures are located in the bottom right corner of the page. The first signature, 'G. L. B.', is written in a cursive style. The second signature, 'C. A. B.', is also in cursive and appears to be a shorter, more compact signature.

4. **Declaration of Results** shall be posted:

- a) in the Municipal Office; and
- b) in the Post Office in the Town of Wapella; and
- c) on the Municipal Website ([www.rmofmartin.com](http://www.rmofmartin.com)); and
- d) emailed to RM Ratepayers who have agreed to receive emails;
- e) on Ministry of Government Relations *Report Municipal Election Results* form; and
- f) Council Member information updated on the Municipal Directory on the Government of Saskatchewan website; and
- g) Council Member information updated on the SARM RM Directory
